The primary purpose of any law enforcement agency is to safeguard the lives and property of the citizens which it serves. In regard to firearms, the Huntsville Police Department has a responsibility to insure that all facets of the law are addressed, and that no weapon--which is in our possession--is released to any person forbidden to possess that weapon.

For these reasons, the following information must be furnished prior to the release of any weapon.

On the reverse side of this form are excerpts from Federal and Alabama law regarding firearms; Please read them now. These laws prohibit the following persons from possessing firearms:

A. Any person who is under indictment for a criminal offense which would constitute a felony; or for which a sentence in excess of one year may be imposed.

C. Any person who is a fugitive from justice.

E. Any person who has been adjudicated as mentally defective; or has been committed to a mental institution.

G. Any person who is an alien unlawfully in the United States.

B. Any person who has been convicted by a court of law for a criminal offense which would constitute a felony or crime of violence; or has been sentenced by a court of law to imprisonment in excess of one year.

D. Any person who is a user of, or addicted to, marijuana or a depressant, stimulant, or narcotic drug; or who is a habitual drunkard

F. Any person who received a Dishonorable Discharge from the Armed Services of the United States.

H. Any person who renounced their citizenship of the United States.

D LAWS PERTAINING TO FIREARMS

FEDERAL LAW

Under Title 18 of the United States Code, it is unlawful for any of the following persons, to possess, transfer or cause to be transferred, a firearm: Any person who . . .

- 1). is under indictment for a felony offense
- 2). is a fugitive from justice
- 3). is an unlawful user of, or addicted to marijuana or any depressant or stimulant or narcotic drug
- 4). has been adjudicated as mentally defective or has been committed to a mental institution

ALABAMA LAW

Alabama law prohibits the following persons from possession of a handgun:

- 1). One who has been convicted in this State, or elsewhere, of committing or attempting to commit a crime of violence
- 2). One who is a drug addict or a habitual drunkard
- 3). One who is a minor
